EDUCATION

Strathmore Business School's Managing Healthcare Business (MHB) Courses are offered at two different levels:

- The Executive Managing Healthcare Business Course is designed for experienced, academically schooled, healthcare managers in public and private healthcare facilities, with a view to deepening their management knowledge and expertise and applying learnings to their healthcare facility. The course is divided into four modules of four days, spanning a period of eight months.
- The Foundations of Managing Healthcare
 Business Course is a five day introduction
 course designed as a bridge to the Executive Course, for managers with a few years
 of experience in the field, aspiring an advanced career in healthcare management.
 The Foundations course introduces the key
 foundations for sound healthcare management. It follows the same curriculum as
 the Executive Course but in a more concise
 mode.

COACHING

Following the courses at Strathmore, you will receive two one-on-one coaching sessions with a certified professional coach. This Executive Coaching is specifically designed to enable you to rise above the scope of formal management and develop creative solutions for the challenges facing you in your business today.

Coaching helps you to think strategically and teaches you to inspire a shared vision, mission and values in your organization. During these sessions you will also review your leadership style and introduce changes to interrupt negative habits. Coaching elicits a high commitment to personal change and development.

WORK

The work pillar consists of hands-on business support. Advisors from PharmAccess' Health Management Solutions (HMS) team look into the functioning of specific areas of healthcare management such as human resources, clinical operations, information management, inventory management, and book keeping, amongst other business proponents, with the purpose of detecting obstacles and addressing them to optimize performance in all relevant areas.

Fees and Scholarships

The Executive MHB Course, followed by two coaching sessions and five days of individual on-site support is now offered at a temporarily reduced rate of **KES 250,000**. When procured separately the Executive course followed by two coaching sessions is priced at **KES 200,000**; the Foundations Course is priced at **KES 80,000**.

Advisory services can be procured in combination with the MHB course or separately. Prices

depend on the size of the assignment (number of work days) and the seniority of the advisor. Attractive financing options are available, including health education loans that allow you to pay back the tuition fee in terms at close to zero interest.

Per academic year PharmAccess has three full scholarships to offer to the healthcare facilities in its network that are most committed to improving quality and value proposition.
